Overview

Effective October 05, 2013, new Iridium 9505A USB to Serial cable for Iridium AxcessPoint accessory is available for ordering. This cable provides customers the flexibility to connect their Iridium 9505A satellite phone with an Iridium AxcessPoint device and establish a Wi-Fi hotspot.

The Iridium 9505A USB to Serial cable for Iridium AxcessPoint is designed to connect with an RS232 data adapter, which is attached to Iridium 9505A satellite phone, with an Iridium AxcessPoint device. Users must have the RS232 Data adapter (available separately for purchase on Iridium website, part number RDA0401) in order to establish a successful data



 $connection\ between\ Iridium\ Axcess Point\ device\ and\ Iridium\ 9505A\ hand set.$

The USB to Serial cable comes with a pre-installed firmware that allows customers to establish a seamless data connection between Iridium 9505A satellite phone and Iridium AxcessPoint device.

<u>Important note</u>: Iridium AxcessPoint firmware should be upgraded to version 2.6.5 for establishing connectivity with Iridium 9505A handsets. The firmware and upgrade instructions can be downloaded from this location:
